

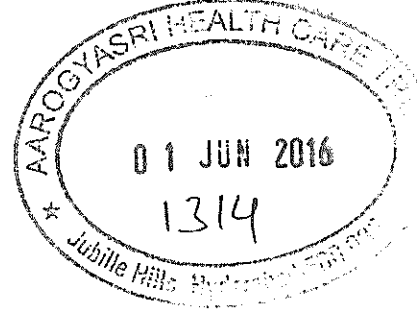

I am to invite your attention to the reference 2<sup>nd</sup> cited. The Aarogyasri Health Care Trust is governed by Deed of Trust of Aarogyasri Health Care Trust registered on 24-08-2007 vide Document No.278 of 2007 and Supplemental Deed of Trust registered on 28-09-2010 vide Document No.299/IV/2010. The Aarogyasri Health Care Trust is included in 'X' Schedule of A.P. Reorganization Act, 2014.

2. As per section 101 of the Andhra Pradesh Re-Organisation Act, 2014 (Central Act No.6 of 2014), the State of Telangana is empowered by order, to make such adaptations and modifications of any law made before 02-06-2014, whether by way of repeal or amendment as may be necessary or expedient, for the purpose of facilitating the application of such law in the State of Telangana before expiration of two years from 02-06-2014 and thereupon every such law shall have effect subject to the adaptations and modifications so made until altered, repealed or amended by a competent Legislature or other competent authority.

3. Therefore, it has become necessary to adapt, "Deed of Trust of Aarogyasri Health Care Trust registered on 24-08-2007 vide Document No.278 of 2007 and Supplemental Deed of Trust registered on 28-09-2010 vide Document No.299/IV/2010" in force as on 01-06-2014 for the purpose of facilitating its application in relation to the Aarogyasri Health Care Trust.

4. After careful examination, Government have decided to permit the Aarogyasri Health Care Trust to adapt the said Deeds of Trust which are in force as on 01-06-2014.

(Amendments to the Deed of Trust registered vide Document No.278 of 2007, dated 24.08.2007 and the Supplemental Deed of Trust registered vide Document No. 299/IV/2010, date 28/9/2010)

THIS DEED OF TRUST is executed on this the ~~28<sup>th</sup>~~ day of ~~Feb~~ <sup>Seventeen</sup> Two Thousand and ~~Sixteen~~ at Hyderabad by the GOVT. OF TELANGANA represented by its Principal Secretary, Health, Medical & Family Welfare Department, Government of Telangana.

In continuation of earlier Deed of Trust registered on 24<sup>th</sup> August, 2007 vide Document No. 278 of 2007 and followed by Supplemental Deed of Trust registered on 28<sup>th</sup> September, 2010 vide Document No. 299/IV/2010, the Trust proposed to make some amendments to certain Bye Laws in view of formation of the State of Telangana on reorganization of the State of Andhra Pradesh as per the Andhra Pradesh Reorganization Act, 2014 (Central Act No. 6 of 2014) and inclusion of Aarogyasri Health Care Trust in the X Schedule of the said Act published in Gazette of India No. 294 Notification Dt:07.05.2015 of Ministry of Home Affairs. The amendments are necessitated in the above context and for smooth functioning of the Aarogyasri Health Care Trust to provide better Medical care to the BPL families in the state of Telangana.

In exercise of the powers conferred by section 101 of the Andhra Pradesh Reorganization Act, 2014 (Central Act No. 6 of 2014), the Deed of Trust of Aarogyasri Health Care Trust registered on 24<sup>th</sup> August, 2007 vide Document No. 278 of 2007 and Supplemental Deed of Trust of Aarogyasri Health Care Trust registered on 28<sup>th</sup> September, 2010 vide Document No. 299/IV/2010, which were in force in the State of Andhra Pradesh immediately before formation of the State of Telangana, are hereby adapted to the State of Telangana, subject to amendments mentioned in the Supplemental Deed of Trust and shall be in force in the State of Telangana until repealed or amended.

By invoking the powers vested in Bye-Laws 3(c), 5(x) and 19 of Deed of Trust, Dt: 24-08-2007, the Trust proposed to make some amendments to certain Bye-Laws of Deed of Trust of Aarogyasri Health Care Trust, Dt: 24-08-2007 (Document No. 278 of 2007) and Supplemental Deed of Trust of Aarogyasri Health Care Trust, Dt: 28-09-2010 (Document No. 299/IV/2010) for smooth functioning of the Aarogyasri Health Care Trust to provide better medical care to the BPL families in the State of Telangana.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOW:


I. In the Deed of Trust of Aarogyasri Health Care Trust, Dt: 24-08-2007 and Supplemental Deed of Trust of Aarogyasri Health Care Trust, Dt: 28-09-2010, throughout the Deeds,

(a) for the words "Andhra Pradesh" wherever they occur, the word "Telangana" shall be substituted;

(b) the word "Rajiv" wherever it occur shall be omitted;

(c) for the expression "GoAP" wherever it occur the expression "GoTS" shall be substituted;

(d) for the expression "AP" wherever they occur, the expression "TS" shall be substituted.



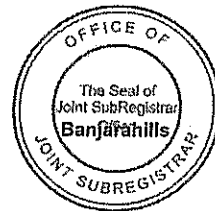

II. In Bye-Law 2(b) of Deed of Trust, Dt: 24.08.2007, for the words "3<sup>rd</sup> FLOOR MUNICIPAL COMPLEX, BESIDES KOTI MATERNITY HOSPITAL, SULTAN BAZAR, KOTI, HYDERABAD - 500 001" the following words shall be substituted,-

"Door No. 8-2-293/82/a/ahct, Road No.46, Jubilee Hills,Hyderabad - 500 033"

III. In Supplemental Deed of Trust of Aarogyasri Health Care Trust, Dt: 28-09-2010,-

(a) Bye-Law No."5" shall be re-numbered as "4".

(b) clause (b), under Bye-Law 4, shall be substituted with clause(a).

(c) in Bye-Law 4 a),- in the table,

(i). at Sl. No. 2, the "Hon'ble Minister for Aarogyasri, 104, 108, Medical Infrastructure and Health Insurance" shall be substituted with the following, namely:-

"Hon'ble Minister for Health, Medical & Family Welfare, Government of Telangana"

(ii). Sl.No." 10. Director of NIMS" and "Trustee" shall be omitted and Sl.Nos 11& 12 shall be renumbered as Sl.Nos 10& 11.

(IV). In the Appendix to the Deed of Trust, Dt: 2.08.2007,-

(a) in the title the words "Population 3 districts of Andhra Pradesh" shall be omitted.

(b) clause "3.0" and "Note" there under shall be substituted with the following namely,--


" 3.0 Beneficiaries:

The Aarogyasri Scheme or any other health scheme(s) under the Trust of the Govt. of Telangana, is intended to benefit below poverty line (BPL) population in all the districts of the State of Telangana. Database and photograph in electronic format of these families is available in white ration cards issued by the Civil Supplies Department."

"Note : Such of the white ration card holders/or other card holders prescribed under the scheme, who are covered for the specified diseases by other insurance schemes such as CGHS, ESIS, Railway, RTC etc., will not be eligible for any benefit under the scheme."

(c) for clause 3.2, the following shall be substituted, namely,--

"Govt. of Telangana/ Trust will provide the details of each BPL family and other beneficiaries covered under the Scheme(s) electronically through the prescribed House Hold Card or any other card identified under the Scheme. This card will be a part of enrolment / identification for availing the health facility. "

(d) for clause 4.0, the following shall be substituted, namely,--

"The Scheme(s) shall provide coverage for meeting expenses of hospitalization and surgical procedures of beneficiary members up to Rs.2.00 lakhs per family per year subject to limits, in any of the network hospitals. The Benefit on family will be on floater basis i.e. the total reimbursement of Rs. 2.00 lakhs can be availed of individually or collectively by members of the family. "

(e) For clause 5.0, the following shall be substituted, namely,--

"There is a provision to provide an additional sum as Buffer/ corporate floater to take care of expenses, if it exceeds the original sum of Rs. 2.00 lakhs per family. In such cases an amount up to Rs.50000/- per family shall be additionally provided, as decided by the Trust."

(f) in clause 6.0, after sub-clause h), under 'Hospitals should be in a position to provide following additional benefit to the BPL beneficiaries related to identified systems', for sub-clause "c", the following shall be substituted, namely,--

"c. Minimum number of free Health Camps in villages/towns/cities in an year for the screening of the BPL patient suffering from the identified ailments, as decided by the Trust. Villages/towns/cities shall be identified in consultation with the Trust.

(The above is subject to the Guidelines/eligibility criteria of the empanelment of hospitals issued by the Trust from time to time.)"

(g) clause "7.0" shall be omitted.

(h) for clause "8.0", the following shall be substituted, namely,--


"Aarogyasri Health Care Trust is a nodal agency for the implementation of the Aarogyasri Scheme to provide the health care services to BPL families for the surgeries / therapeutic procedures, for which purpose it had created a network of Service Providers. The Aarogyasri scheme is providing the cashless health benefit cover for tertiary and secondary care medical and surgical therapies and follow up therapies in the identified network of hospitals to the identified beneficiaries with the financial limit of Rs.2.00 lakhs per family, under the scheme of the trust. It is catering the health services to the poor in the identified procedures in its empanelled network hospitals in all the Districts of Telangana. Further, the Trust continues to provide the health services with respect to the Chief Minister Camp Office(CMCO), Cochlear and the Journalist scheme to the eligible beneficiaries and other Schemes under the Trust."

V. for clause "21" , in Annexure-1 to the Deed of Trust, Dt: 24.08.2007, the following shall be substituted, namely:--

"Package includes end to end cashless service from the time of reporting of the patient till 10 days post discharge medications including complications if any up-to 30 days postop discharge.

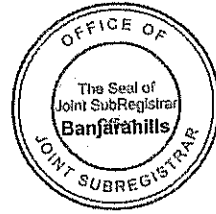

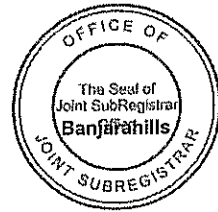
