**ORDER:-**

In the departmental review meeting taken up by the Hon'ble Chief Minister it was observed that smooth and effective functioning of the Hospitals is hampered for want of sufficient funds at the disposal of the Superintendents of the Hospitals. Therefore the Hon'ble Chief Minister has desired that sufficient budget should be allocated at the disposal of the Hospital Superintendents at the beginning of the Financial Year so as to enable them to attend to the urgent needs of the Hospital for the smooth and effective functioning.

2 In order to ensure smooth and effective functioning of the Hospitals Government has made necessary budgetary provision towards contingency fund for the financial year 2016-17 to all the Heads of the departments.

3 In the reference 4<sup>th</sup> read above, the Director of Medical Education, Hyderabad has proposed certain measures to be taken on the delegation of powers to Superintendents with regard to financial and administrative matters.

4 The Government after careful examination of the proposal here by delegate the power of expenditure up to Rs.10.00 lakhs per case with a maximum of Rs.1.00 crore per financial year to the Head of the Departments / Superintendents of all Teaching Hospitals under the control of Director of Medical Education, Hyderabad, all District Hospitals, Area Hospitals, Community Health Centers and Public Health Centers under the control of Commissioner, Telangana Vaidhya Vidhana Parishad / Director of Public Health & Family Welfare, TS, Hyderabad, All District Medical and Health Officers under control of Director of Public Health & Family Welfare and all the Superintendents of Ayush from the contingency fund allocated for the purpose, duly depositing the same into their P.D. accounts.

5 The Government hereby also enhance the existing limit duly modifying the orders 3<sup>rd</sup> read above for spending budget in the accounts of Hospital Development Society (HDS) from Rs.5.00 lakhs to Rs. 25.00 lakhs per case and up to 1 crore per financial year.

6 Government also permit Superintendents to spend up to Rs.25 lakhs per case basis from the account of Arogyasree budget up to Rs.1 crore per financial year for the maintenance of equipments and infrastructure.

7 The Government hereby also permit depositing of the total revolving funds generated in Arogyasree in to the Hospital Superintendents accounts.

8 Above expenditure shall be done duly following normal State Government Rules.
