Further, the Government hereby authorize the Director of Medical Education, Hyderabad to issue necessary sanction orders for the amounts shown at Sl.Nos.1 to 3 for drawing and adjusting the amount of Rs.64,75,00,000/- (Rupees sixty four crores and seventy five lakhs only) to the P.D. A/c No.326 of Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad.

3. The bills shall be presented to District Treasury, Hyderabad (Urban) by the concerned DDO, O/o the Director of Medical Education, Hyderabad. The District Treasury, Hyderabad (Urban) after crediting the amount of Rs.64,75,00,000/- (Rupees sixty four crores and seventy five lakhs only) to the P.D. A/c No.326 of Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad intimate the fact to the Director of Medical Education and the Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad.

4. As regards drawal of funds, the Director of Medical Education shall follow the procedure as envisaged above. Further, the Government hereby authorize the Director of Medical Education, Hyderabad to issue necessary sanction orders for the amounts shown at Sl.No.4 for drawing and adjusting the amount of Rs.41,66,000/- (Rupees forty one lakhs and sixty six thousands only) to the P.D. A/c No.238 of Director of Medical Education, Hyderabad and at Sl.No.5 for drawing and adjusting the amount of Rs.25,00,000/- (Rupees twenty five lakhs only) to the P.D.A/c No.213 of TSMSIDC, Hyderabad and intimate the fact to the Managing Director, TSMSIDC, Hyderabad

5. The bills shall be presented to The District Treasury, Hyderabad (Urban) by the Assistant Accounts Officer, O/o Director of Medical Education, Hyderabad and the Concerned DDO. The District Treasury, Hyderabad (Urban) after crediting the amount Rs.41,66,000 /- (Rupees forty one lakhs and sixty six thousands only) to the P.D. A/c No.238 of Director of Medical Education, Hyderabad and at Sl.No.5 for drawing and adjusting the amount of Rs.25,00,000/- (Rupees twenty five lakhs only) to the P.D.A/c No.213 of TSMSIDC, Hyderabad respectively, intimate the fact to the Managing Director, TSMSIDC, Hyderabad and the Director of Medical Education, Hyderabad.

6. The amount deposited in the P.D Account shall be drawn with reference to the need and amount so drawn shall be utilized for the purpose for which it is released. The amount deposited in the P.D Account shall not be drawn for depositing in any Bank by any authority.

7. The Director of Medical Education, Hyderabad, the Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad and the Managing Director, TSMSIDC, Hyderabad shall take necessary action in the matter, utilize the funds for the intended purpose and furnish the utilization certificate/Statement of Expenditure to Government for the amount sanctioned at para- 1 above.
