ORDER:

In the reference read above, the Chief Executive Officer (CEO) of the Rajiv Aarogyasri Health Care Trust, Hyderabad, has informed that the Phase-IV and Phase-V (Second Renewal) of Rajiv Aarogyasri Health Insurance Scheme for 352 procedures of Aarogyasri-I is coming to an end on 16.07.2011 in ten districts namely, Adilabad, Hyderabad, Kurnool, Vizianagaram, Visakhapatnam, Nizamabad, Khammam, Warangal, Guntur and Krishna.

2. The C.E.O. of the Aarogyasri Health Care Trust, Hyderabad, has requested the Government to approve the Bid Documents and authorize him to launch the procurement process for sourcing the most competitive health insurance company through a transparent process for the management of health insurance Scheme in ten districts of Adilabad, Hyderabad, Kurnool, Vizianagaram, Visakhapatnam, Nizamabad, Khammam, Warangal, Guntur and Krishna for the period from 17.07.2011 to 16.07.2012.

3. The Government, after careful examination of the matter, hereby approve the Bid Documents which are annexed to this order and authorize the CEO of Aarogyasri Health Care Trust, Hyderabad, to launch the procurement process for sourcing the most competitive insurance company and a third party administrator (TPA) for the management of two distinct sets of procedures respectively in ten districts under Phase-IV and Phase-V for the period from 17.07.2011 to 16.07.2012.


