ORDER:

In the review meeting of the Aarogyasri Health Care Trust, held during the month of November, 2009 under the Chairmanship of Hon'ble CM, it was observed that there is a need for streamlining the method of procurement of various kinds of implants under Aarogyasri and that a committee of experts should be constituted with clear terms of reference. Accordingly, the following committee of experts is constituted under the chairmanship of Director of Medical Education with specialists in the areas of Cardiology, Orthopedics and CT surgery drawn from the Government and Autonomous institutions:-

4. Dr.B.T.Prasad, Prof. Cordio Thoracic Surgeon, GMC/Gandhi Hospital, Secunderabad - Member
5. Dr.V.Murali Mohan, Chief Medical Audit Officer, Aarogyasri Health Care Trust, Hyderabad - Member

2. The Committee may consult other experts in Government and Private Sector as necessary.

3. The terms of reference of the committee are as follows:-

1. Listing of the various kinds of implants used under Aarogyasri.
2. Definition of the internationally accepted standards and specifications for each category of implants;
3. Listing out of the implants approved by the FDA as well as the DCGI
4. Recommending wherever possible, the range of costs for various kinds of implants;
5. The procedures recommended for procurement of the stents/implants by the Superintendents/Directors of the respective hospitals;

4. The Committee may consult other experts in Government and Private sector as deemed necessary.
5. The above committee shall submit its report within a period of two weeks.
6. The Director of Medical Education shall take necessary action in the matter accordingly.
