HM&FW Department – Strengthening of Hospitals under Director of Medical Education and A.P. Vaidya Vidhana Parishad – Allotment of Rs.50.00 Crores from C.M.R.F. to A.P.H.M.H.I.D.C., Hyderabad – Orders – Issued.

ORDER: -

It is noticed that the poor performance of Government Hospitals in the Aarogyasri Scheme is due to (a) lack of infrastructure like the equipment and exclusive/ well maintained Aarogyasri wards; (b) posts of Specialists and Surgeons being vacant, especially in the District and Area Hospitals; and (c) poor management at various levels.

2.1 The matter was reviewed by the Honourable Chief Minister in the meeting of the Board of Aarogyasri Trust held on 29.04.2010. It has been decided to allot an amount of Rs.50.00 Crores for strengthening the infrastructure in the Government Hospitals, to improve their performance. This amount is proposed to be derived from the contribution of Chief Minister's Relief Fund (CMRF) to Aarogyasri releases from time to time by the Government in Revenue Department. This amount will be in-addition to the Rs.20.00 Crores of the amount deducted by the Aarogyasri Trust from the payments made to the Government Hospitals for Aarogyasri Surgeries. A Committee of officers headed by the Managing Director, Andhra Pradesh Health & Medical Housing & Infrastructure Development Corporation, Hyderabad, consisting of Director of Medical Education, Commissioner, A.P. Vaidya Vidhana Parishad, Hyderabad and Chief Executive Officer, Aarogyasri analyzed the requirements of various Hospitals and prepared an Action Plan for enhancing the infrastructure.

3. It has been decided to take up strengthening the infrastructure in 17 Hospitals under the control of Director of Medical Education, as per the list shown in Annexure-I, at an estimated cost of Rs.35.00 Crores and 24 Hospitals under the control of Andhra Pradesh Vaidya Vidhana Parishad, as per the list shown in Annexure-II, at an estimated cost of Rs.20.00 Crores. Civil Works and up-gradation of Wards are also proposed to be undertaken in Director of Medical Education and A.P. Vaidya Vidhana Parishad Hospitals at a cost of Rs.5.00 Crores in each department.

4. Government after careful consideration hereby approve the following "**Scheme for up-gradation of infrastructure in Government Hospitals**" to improve their performance under Aarogyasri Programme.

a) The following amount are sanctioned for procurement of equipment and upgradation of Wards: -

b) The project involves procurement of about 300 items of equipment for different Departments besides site preparation and equipment maintenance. As the entire exercise is to go in a planned, systematic and in a time bound manner, the entire work shall be entrusted on a turn-key basis to a single company or to a consortium of 2 companies, with a comprehensive responsibility of supply and installation of equipment, site preparation and maintenance of equipment for 5 years.

c) **Project Management Units (PMUs)** shall be created in the office of the Director of Medical Education and A.P. Vaidya Vidhana Parishad for monitoring the purchase, installation and utilization of equipment under Aarogyasri.

d) The Andhra Pradesh Health & Medical Housing & Infrastructure Development

5. Government after careful consideration hereby order for allotment of **Rs.50.00 Crores (Rupees Fifty Crores only)** to the Andhra Pradesh Health, Medical and Housing and Infrastructure Development Corporation (APMHIDC) from the Chief Ministers Relief Fund (CMRF) for implementing the above project of Strengthening Infrastructure and amenities in the Teaching, Speciality, District and Area Hospitals for improving the performance under Aarogyasri Scheme. Government also direct utilization of an amount of Rs.15.00 Crores from the Recurring fund available with the Trust, for this purpose.

6. Government also hereby Constitute a **Steering Committee** for implementation and monitoring of the Project with the following Members with powers to take all operational decisions.

7. The Revenue (CMRF) Department shall issue consequential orders for release of Rs.50.00 crores from Chief Minister's Relief Fund (CMRF) to the Managing Director, Andhra Pradesh Health & Medical Housing & Infrastructure Development Corporation, Hyderabad immediately.

8. The Managing Director, Andhra Pradesh Health & Medical Housing & Infrastructure Development Corporation, Hyderabad shall take further necessary action.

9. This order issues with the concurrence of Revenue Department vide their U.O. No. 32580/CMRF/2010, dated:15-7-2010 and Finance (Expr.M&H-I) Department vide their U.O.No.9269/179/A1/Expr.M&H-I/2010, dated:19-7-2010.
