ORDER: -

In the circumstances reported by the Chief Executive Officer, Aarogyasri Health Care Trust in the reference read above, the Government hereby permit the Aarogyasri Health Care Trust to continue implementation of "Rajiv Aarogyasri Health Insurance Scheme – Phase-II", on its own, which was launched on 05.12.2007 for fifth year, i.e., 4th Renewal, for five districts, viz., East Godavari, West Godavari, Chittoor, Nalgonda and Ranga Reddy, for the period from 05.12.2011 to 31.03.2013 in order to synchronise the dates to the end of financial year, for 192 (one hundred and ninety two) procedures under both Aarogyasri – I & II, covering all the BPL families, identified by the Civil Supplies Department and Rajiv Aarogyasri Health Cards.

2. The Government also accord permission to the Chief Executive Officer, Aarogyasri Health Care Trust to launch a competitive bidding process in a transparent and fair manner for selection of an Insurer at the least cost to Government. The Tender Committee (technical and financial) of the Trust is authorized to initiate the process as per procurement policy of the Trust.

3. The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad shall take necessary further action in the matter, accordingly.
