ORDER

The Board of Trustees of AarogyaSri Health Care Trust in its Resolution No.28/2007 of September, 2007 have resolved for construction of a building for the Trust office on the land allotted by the Government to the Trust in Survey No.403, Block-E, Ward No.9 of Shaikpet Village, Hyderabad.

2. In the letter read above, the Managing Director, APMHIDC, Hyderabad has furnished detailed structural drawings and estimates for a value amounting to Rs.4.92 crores. The description of items and the estimates include land development, laying of roads, civil works, interior works etc. to be taken up on a turn key basis.
3. The Chief Executive officer, AarogyaSri health Care Trust has requested the Government to accord administrative sanction for construction of the building at the estimated cost of Rs.4.92 crores.
4. Government after careful examination hereby accord administrative sanction to construct the Trust building in Survey No.403, Block-E, Ward 9 of Shaikpet Village at an estimated cost of Rs.4.92 crores. The expenditure shall be met from the budget of Health, Medical & Family Welfare Department. The Construction work shall be estimated through APMHIDC, Hyderabad.
5. The Chief Executive Officer, AarogyaSri Health Care Trust is requested to take necessary action accordingly.
