During the twin Bomb Blasts that occurred at Dilsukhnagar, Hyderabad on 21.02.2013, over 16 people died on 22.2.2013 and several persons were injured and taken into the various Government / Private Hospitals for immediate medical relief.

2. Government have decided to provide cashless medical treatment to the victims of the above bomb blast.

3. Government after care full examination hereby issue the following orders with immediate effect, as a special case to the victims of the bomb blast on 22.02.2013.

a) The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad is hereby permitted to provide cashless treatment duly relaxing the limit of Rs.2 lakhs per patient for all the victims of the Bomb Blast ie., who were admitted and getting treatment in the Aarogyasri empanelled hospitals and the expenditure of the treatment of the victims shall be borne from the funds of Aarogyasri Health Care Trust.

b) The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad shall identify the victims of the bomb blast, with the assistance of District Collector concerned, where they are taking treatment in Private hospitals which are not included in the Aarogyasri Health Care Trust network and effect payment for the expenditure incurred to the hospital duly following the established procedure for reimbursement of expenditure for the Private hospitals. The limit of Rs.2.00 lakhs per patient will not apply in this case.

4. The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad shall take immediate necessary action accordingly.

5. This order, issue with the concurrence of Finance Department vide U.O.No.2207/177/A2/Exp.M&H/2013, dt.27.2.2013.
