ORDER:

The Govt. has established Aarogyasri Health Care Trust, to oversee the implementation of the Rajiv Aarogyasri Health Insurance Scheme through an identified insurer and has implemented the scheme on pilot basis with effect from 1-4-2007 in three districts and later the scheme has been expanded to all the twenty three districts of the State with effect from 17-7-2008.

2. In order to strengthen the Scheme and its implementation, the Government, in the reference 1<sup>st</sup> read above, has accorded administrative sanction for creation of certain executive posts among other posts, in the Aarogyasri Health Care Trust, Hyderabad with effect from 01.04.2007 to be filled up on contract basis and specified consolidated remuneration in respect of each post.

3. In the references 2<sup>nd</sup> and 3<sup>rd</sup> read above, the Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad has stated that in view of the enhancement of pay structure to the Government Employees on account of Revised Pay Scales, 2010 and enhancement of consolidated pay structure to Contract Employees with effect from 1-2-2010, it was approved for enhancement of remuneration of the said Contract Employees working in the Trust and to meet the additional financial implication from approved administrative budget of the Trust, as per Resolution of the Board of Trustees in their 13<sup>th</sup> Meeting held on 29.04.2010.

4. The Chief Executive Officer, Aarogyasri Health Care Trust has therefore requested the Government for implementation of the said resolution for enhancement of remuneration to the above said Contract Employees working in the Aarogyasri Health Care Trust.

5. After careful examination of the matter, Government hereby order that the remuneration of the Contract Employees working in the Aarogyasri Health Care Trust be enhanced as shown below, meeting the additional expenditure from the budget allocation of the Trust only: -

6.	Dy. E.O. (Non-Tech)	Rs.30,000/-
7.	District Coordinators	Rs.35,000/-

6. These orders shall come into force with immediate effect and the claims of enhanced remuneration shall be allowed with effect from the date of issue of these orders only.

7. The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad, shall take necessary further action accordingly.


