ORDER: -

The Government has decided to provide comprehensive health care to all Government Employees, Pensioners and their family members, on cashless basis, through an appropriate scheme in lieu of the present age old medical reimbursement system. In order to implement the Scheme effectively, the Government has conducted a series of meetings with the Joint Action Committee of Employees, Teachers, Workers and Pensioners and Andhra Pradesh Secretariat Employees' Co-ordination Committee representatives to discuss the scheme and its implementation modalities. Based on the inputs received during these meetings, the Government has decided to operationalise a scheme for comprehensive health care for employees, pensioners and their families in a time bound manner.

2. In furtherance of the above decision, Government, in the G.O. 1st read above, has constituted a 17-Member Technical Committee, under the Chairpersonship of the Commissioner of Public Health & Family Welfare, Andhra Pradesh, Hyderabad, to analyze all aspects of the scheme and make comprehensive recommendations for its effective implementation, after due deliberations with all stakeholders and experts on the subject.

3. In the letter 2nd read above, the Commissioner of Public Health & Family Welfare, Andhra Pradesh, Hyderabad, who is the Chairperson of the Technical Committee has reported that the Committee, after negotiations with the employees associations, has offered certain recommendations, proposing to entrust the responsibility of implementation of the Scheme initially to Aarogyasri Health Care Trust and to review the performance thereof from time to time by the said Trust.

4. Further, the Commissioner of Public Health & Family Welfare, Andhra Pradesh, Hyderabad, has reported that the Committee has also proposed to constitute a State Level Committee to examine and finalise their recommendations and to monitor implementation of the Scheme, after it is launched.

5. The Government, after careful examination of the matter, has decided to accept the proposal of the Technical Committee and accordingly hereby constitutes a State Level Committee with the following members to examine the recommendations of the Technical Committee and to offer recommendations on all modalities to be adopting finally and to monitor the implementation of the new Scheme after launching: -

2. Prl. Secretary to Govt., Finance Dept. Member
3. Prl. Secretary to Govt., G.A. Dept. Member
4. Commissioner of Civil Supplies, A.P., Hyd. Member
5. Commissioner of PH & FW, A.P., Hyd. Member
6. Director of Treasuries & Accounts, A.P., Hyd. Member
7. Director of Medical Education, A.P., Hyd. Member
8. Pay & Accounts Officer, Hyderabad Member
9. CEO, AHCT, Hyd. Member Convener
10. A representative of A.P.N.G.O.'s Association Special Invitee
11. A representative of T.N.G.O.'s Central Union Special Invitee

6. The Committee is authorized to include any other Member or Members to the State Level Committee as and when necessary, and offer their recommendations within a month.
7. The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad shall take necessary further action in the matter accordingly.
