ORDER :

In the reference 2<sup>nd</sup> read above, the Commissioner A.P. Vaidya Vidhana Parishad has submitted a status note on the implementation of Rajiv Aarogyasri Health Insurance Programme in some of the selected hospitals of A.P. Vaidya Vidhana Parishad and requested for release of additional funds to a tune of Rs.1.30 crores for procurement of equipment and strengthening of infrastructure in hospitals under A.P. Vaidya Vidhana Parishad, which are included in the Aarogya Sri Network.

The Government after careful consideration of the issue, hereby decide and accordingly order for release of Rs.1.30 crores (Rupees one crore and thirty laksh) from out of the revolving fund available with "Aarogyasri" Health Care Trust to the Commissioner, A.P. Vaidya Vidhana Parishad towards strengthening the infrastructure in the selected hospitals of the A.P. Vaidya Vidhana Parishad.
3. The Chief Executive Officer, Aarogyasri is requested to take necessary action accordingly.
4. The Commissioner, A.P. Vaidya Vidhana Parishad shall follow prescribed procedure for procurement of equipment etc through Andhra Pradesh Health, Medical Housing and Infrastructure Development Corporation (APMHIDC) and maintain proper stock accounts and aim at enhancing its participation under Aarogyasri scheme, the prime objective as envisaged in the G.O.1<sup>st</sup> read above.
