ORDER:

In the G.O. 1st read above, orders were issued permitting the Aarogyasri Health Care Trust to implement Rajiv Aarogyasri Health Insurance Scheme for the fifth year in three districts namely, Ananthapur, Srikakulam and Mahaboobnagar of Phase-I for the period from 05.04.2011 to 04.04.2012 and for the fourth year in five districts namely, Medak, Karimnagar, Prakasam, S.P.S.R. Nellore and Kadapa of Phase-III for the period from 15.04.2011 to 14.04.2012 for 938 procedures of both Aarogyasri-I and II. Further, Government also accorded permission to the Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad, to conduct competitive bidding process for selection of the most competitive Insurance Company with the approval of the Finance and Technical Committees in accordance with the standard operating procedures and obtain approval of the Executive Committee for execution of Memorandum of Understanding.

2. The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad, vide reference 2nd read above, informed that the Aarogyasri Health Care Trust has conducted the Bid Committee Meeting on 04.03.2011 for continuation of Rajiv Aarogyasri Health Insurance Scheme in (8) Districts i.e., fifth year in three districts namely, Ananthapur, Srikakulam and Mahaboobnagar of Phase-I for the period from 05.04.2011 to 04.04.2012 and for the fourth year in five districts namely, Medak, Karimnagar, Prakasam, S.P.S.R. Nellore and Kadapa of Phase-III for the period from 15.04.2011 to 14.04.2012 for 938 procedures of both Aarogyasri-I and II. The Bid Committee after discussions has recommended and approved the changes in Bid Document in clauses in Section B(i) a,b,c in Part-IV, Section-A, clauses in Section-B(ii), Annexure-2a of Technical Bid, refund clause 13 in bid document and 9 in MOU in respect of refund clauses as well as qualifying criteria. Further, the Bid Committee has also finalised the schedule in calling the Bids for renewal of the said Scheme.

3. Government after careful examination of the matter, hereby accept the recommendation of the Bid Committee and order that the Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad, shall operate the Bid Document Schedule as per changes of clauses in Section B(i) a,b,c in Part-IV, Section-A, clauses in Section-B(ii), Annexure-2a of Technical Bid, refund clause 13 in bid document and 9 in MOU. The Bid document Schedule is enclosed to this order. The competitive bidding Schedule shall be planned appropriately to renew the scheme before 05.04.2011.


