ORDER:

The Chief Executive Officer, Aarogyasri Health Care Trust in the letter 1st read above has submitted that a quote has been obtained from M/s. Godrej & Boyce Mfg. Company Limited for workstations and furniture for its new administrative building and Guest House. The negotiated quote and estimate are for (i) Interior works, Furniture & workstation for Administrative Building at Rs.71,63,325/- (ii) interior works & Furniture for Guest House at Rs.12,64,835/- and (iii) Conferencing System in Conference Hall, Training Hall and Board Room at Rs.23,91,940/-, grand total amounting to Rs.1,08,20,092/-. He has also reported that the equipment will be procured with corporate guarantee for an advance payment. The Chief Executive Officer, has therefore requested for Government's approval in this regard.

2. The Government after careful examination of the matter have decided to accept the above proposal of the Chief Executive Officer and accordingly hereby accord the permission to procure the following items of furniture and interiors from M/s. Godrej & Boyce Mfg. Co. Ltd., on a single quotation basis subject to satisfaction of the reasonableness of the rates quoted:-

- (i) Interior works & Furniture with workstations for Administrative building.
- (ii) Interior works & Furniture for Guest House and
- (iii) Conferencing System

3. The estimated expenditure shall be met from out of the funds released in the G.O.2nd read above, duly following the terms and conditions as laid down therein.

4. The Chief Executive Officer, Aarogyasri Health Care Trust shall take necessary further action in the matter accordingly.

5. This order issues with the concurrence of the Finance Department vide U.O.No.01624-A/143/A1/Expr.M&H.I/09, dated 2-7-2009.
