In the letter 3rd read above the Chief Executive Officer Aarogyasri Health Care Trust has reported that the Managing Director, Andhra Pradesh Health and Medical Housing and Infrastructure Development Corporation has furnished the revised estimate of Rs.7.22 crores for construction of the Trust Building and for procurement of workstations and furniture. In the letter 2nd read above, the Managing Director, Andhra Pradesh Health and Medical Housing and Infrastructure Development Corporation has also advised for obtaining revised administrative sanction for the revised estimated cost of Rs.7.22 crores.
