ORDER:

The Aarogyasri Health Care Trust, Hyderabad, has proposed for an independent evaluation of the Rajiv Aarogyasri Scheme as resolved in the meeting of Board of Trustees held on 17.06.2008 through its Board Resolution No.76/2008 as the ongoing Scheme is three years old now.

2. The Chairman, Planning Commission, Government of India, has recommended the Consortium for independent evaluation of this ongoing Scheme as a prelude for *considering central funding* to the Scheme. Accordingly, the Consortium consisting of Administrative Staff College of India, Hyderabad, Indian Institute of Public Health, Hyderabad, Indian School of Business, Hyderabad and ACCESS Health System International, Hyderabad, has submitted a proposal for evaluation of the Scheme.

3. Further, the Aarogyasri Health Care Trust Board has approved Terms of Reference (ToR) for evaluation of the Scheme by the Consortium and Memorandum of Understanding (MoU) vide Resolution No.207/2010, dated: 07.09.2010. On further discussion with the Special Chief Secretary to Government, Health, Medical & Family Welfare Department, who is Vice Chairman of the Aarogyasri Health Care Trust, certain focus items were added to the terms of references and the Government has approved these extended Terms of References.

4. The Consortium Officials of the Trust held further discussions with the Government and have agreed to carry out the evaluation with the addition of Administrative Staff College of India (ASCI) as a Member of Consortium and with Dr.Mala Rao, as the lead among the Consortium and in the reference 2nd read above, the Director General, Administrative Staff College of India, Hyderabad, has confirmed his willingness to contribute to the evaluation of the Rajiv Aarogyasri Scheme.

5. In view of the above, Government, hereby, authorize the Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad, to enter into Memorandum of Understanding (MoU) with Dr.Mala Rao as lead and Director, Indian Institute of Public Health as another Member of the Core Team. The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad, will work out a revised schedule for the process of evaluation and submission of final report in consultation with Consortium.


