ORDER:

In pursuance of the Government orders issued in the reference read above, by the Finance (Expr.HM&FW-1) Department, the Government hereby issue an administrative sanction order to the Director of Health, AP, Hyderabad for an amount of Rs.40,00,00 Thousand (Rupees forty crores only) towards reimbursement to the PD Account of APHMHIDC, under the budget head of Medical Insurance for BPL Families from the B.E. provision of 2007-08 under the schemes annexed to this order in relaxation of quarterly regulation orders.

2. On presentation of the bills by the Assistant Accounts Officer, O/o Director of Health, Hyderabad and on its admittance, the Pay and Accounts officer, Hyderabad shall credit the amount of Rs. 40,00,00 (Rupees forty crores only) to the P.D. account No.213 of APHMHIDC and intimate the fact to the Managing Director, APHMHIDC, Hyderabad.

3. The amount deposited in P.D. account shall be drawn with reference to the need and amount so drawn shall be utilized for the purpose for which it is released. The amount deposited in P.D. Account shall not be drawn for depositing in any bank by any authority.

4. The Director of Health, Hyderabad shall take necessary action in the matter and furnish the utilization certificates / statement of expenditure for the amount sanctioned as per the annexure appended to this order.
