Speciality Hospital Association (ASHA) and A.P. Nursing Association (APNA) of private hospitals and give its recommendations - Orders – Issued.

In the letter 2nd cited, the Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad has informed that the Aarogyasri Health Care Trust is implementing Rajiv Aarogyasri Health Insurance Scheme in the state for the last five years. He has also informed that the A.P. Speciality Hospital Association (ASHA) and A.P. Nursing Association (APNA) of private hospitals have decided to stall the services in Network Hospitals for Aarogyasri cases. Immediately, the Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad has convened a meeting on 12-12-2012 with A.P. Speciality Hospital Association (ASHA) and A.P. Nursing Association (APNA) of private hospitals to redress their grievances and certain issues were discussed.

2. The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad has further informed that during the above said meeting the following issues were discussed among others.

- i) No deductions should be made from claims submitted by the Network hospitals, and the package amount in full should be paid.
- ii) The evidence asked for claims settlement are numerous in number and need to be reduced.
- iii) The package prices have to be enhanced since the existing prices were fixed in 2007-08 and it is becoming unsustainable to offer services at such prices.
- iv) Employee Health Scheme.

3. With regard to Employees Health Scheme , it is further informed that the Registrar, NTRUHS, Vijayawada has been requested to constitute a technical committee headed by Vice Chancellor, NTR University of Health Sciences, Vijayawada with respective specialist doctors nominated by the Vice Chancellor, NTRUHS to scrutinise the packages, and give its recommendations on the packaging on pricing etc., for taking further action vide Govt. letter 1st cited . The report of said Committee is awaited.

4. The Government, after careful examination of the matter, hereby constitute a Committee with the following members to examine the grievances of A.P. Speciality Hospital Association (ASHA) and A.P. Nursing Association (APNA) of private hospitals and offer their recommendations .
