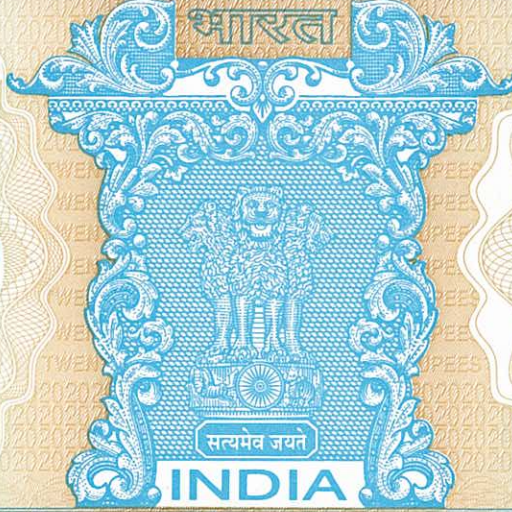

MEMORANDUM OF UNDERSTANDING (Amendment)

This Memorandum of Understanding (Amendment) is executed at Hyderabad on this 2nd day of July 2008 between the Aarogyasri Health Care Trust. (Herein after called the Trust and Party of the



first part) represented by Chief Executive Officer, Aarogyasri Health Care Trust, 3rd Floor, Municipal Commercial Complex, beside Koti Maternity Hospital, Sultan Bazar, Hyderabad - 500095.

AND

Star Health and Allied Insurance Company Limited having its registered office at No. 1 New Tank Street, Valluvar Kottam High Road, Nungambakkam, Chennai – 600 034. as an exclusive insurer for the scheme (herein after called the Insurer and the Party of the second part.) represented by Chairman cum Managing Director

By authority of clause 21 of the MoU signed on 16th June 2008, this agreement witnesseth the following amendments:

8. PERIOD OF INSURANCE:

The insurance coverage under the scheme shall be in force for a period of one year from the date of commencement of the policy. (i.e. from 00.00 hours of 17.07.2008 to 24.00hrs of 16.07.2009)

15. INSURER REPRESENTATIONS, WARRANTIES AND RESPONSIBILITIES

xv. Run-off Period

A “Run Off period “of one month will be allowed after the expiry of the policy i.e., the midnight of 16.08.2009. This





means that preauthorisations can be done till the end of policy period and surgeries for such preauthorisations can be done up to one month after the expiry of policy period and all such claims will be honoured.

This Amendment is executed in two originals, both of which are operative instruments held by both the parties.
